

POLICY INFORMATION FOR CONTACT AND PARTICIPANTS

(Please copy and make sure each participant receives before coming to Glorieta)

Glorieta Standards: Glorieta is a Christian conference center. In keeping with our mission, the following standards help to assure the comfort of our guests:

- Alcoholic beverages, illegal drugs, firearms, and fireworks are **not** permitted.
- Glorieta's facilities are tobacco free, smoking is **not** permitted anywhere on campus.
- Immodest clothing, distasteful monograms, bare feet in public areas, or any extreme style of dress is prohibited.
- Pets are not permitted in any Glorieta facility.
- As a courtesy to all guests, please observe noise curfew from 11:30 pm to 6:30 am.
- Glorieta is not responsible for lost or stolen possessions.

Preservation of Religious Voice and Rights: Glorieta, a facility owned and operated by LifeWay Christian Resources ("LifeWay") of the Southern Baptist Convention ("SBC"), was created predominately for LifeWay and other SBC ministries. Thus, in addition to the above standards designed chiefly to protect the peace and enjoyment of all our guests, LifeWay/Glorieta also imposes religious standards based on the religious faith, purpose, and mission of the SBC, as reflected in the current Baptist Faith & Message (available upon request or by visiting SBC's website at www.sbc.net/2000-bf_m.html). Enforcing these religious standards helps to insure that no activities or views expressed by or through groups using the Glorieta facilities interfere with the ability of LifeWay/Glorieta to speak with one religious voice and promote one religious message consistent with the published views of the SBC. Accordingly, users or guests of the Glorieta facilities must not engage in activities, or publicly declare views, that are contrary to these religious standards as determined by LifeWay/Glorieta. By signing this agreement, you acknowledge and agree that LifeWay/Glorieta retains the right, to be exercised in their sole discretion, to refuse or expel any group or individual that engages in activities or publicly declares views that LifeWay/Glorieta finds substantially inconsistent with their religious standards. Any group or individual expelled from the facilities under this provision may, in LifeWay/Glorieta's sole discretion, be entitled to a partial refund of user fees.

Waiver of Liability/Assumption of Risk and Responsibility: While Glorieta will try to maintain its facilities in good repair, every user of Glorieta's facilities has the obligation to exercise care and caution in using all facilities, grounds, and equipment solely for their intended purposes. By signing this agreement, you acknowledge and agree that every group and/or individual user of Glorieta's facilities:

- (i) assumes the risks inherent in the facilities, grounds, equipment, and activities of Glorieta;
- (ii) will pay for any damage to the facilities, grounds, or equipment that they cause or to which they contribute; and
- (iii) expressly waives and releases LifeWay and Glorieta from liability for any injury or loss occasioned by any use of the facilities, grounds, or equipment of Glorieta that is inconsistent with their intended use or purpose, inconsistent with due care and caution, or inconsistent with the terms of this agreement.

Health Services: Glorieta will assist with 24-hour availability of first aid-trained staff supported by public emergency services.
